DIRECTORS REPORT

M. Kruszynski reported on the following:

<u>Marina</u> – We are launching the boats in the parking lot this weekend. M. Kruszynski invited the board to come out Friday or Saturday to take a look at the process. This is the official start of the season. We're happy the weather is cooperating.

The number permitted slips are as follows: At this time in 2020, we had 272 permitted slips. (We are aware this was the beginning of Covid.) Now, in 2021, permitted slips are 375 - 52 are new boaters. As this is pre-launch, we believe we will get a better handle in the next month on where we will be for the season. The total slips permitted last year was 442.

M. Kruszynski again thanked the board for their help last year with the approving the discounted rate for the displaced Chicago boaters.

T, Kuhn asked about whether we require state registration. He wanted to make sure you can have your boat registered in Illinois and still dock your boat at the Hammond Marina. A discussion was held on the BMV's backlog and what the Marina requires as far as boat registration.

<u>Lost Marsh Golf Course</u> – The course has 169 tee times today. The weather certainly has helped.

<u>Wolf Lake</u> – The staff has been busy with the grass at the parks and the planters at the Water Gardens. They are also planting additional trees.
