Obelisk Plaza Update: M. Kruszynski went before the Hammond Historic Preservation Commission to apply for the Certification of Appropriateness. HE spoke about the improvements from the City of Chicago and are still looking for additional information from ComEd of Illinois. Keith Sattler, Kevin Smith and Milan Kruszynski had a zoom meeting and reviewed plans with Great Lakes Landscaping. Everything is on hold now. Some plantings may need to wait until next season. The limestone has been ordered and K. Sattler has reached out regarding a plaque. K. Smith added the improvement of the sidewalk Alderwoman Garza had installed really makes a difference.

<u>Wolf Lake Parking Lot D</u> – We are currently waiting for the contractor to install everything. They're moving at a slow pace. Lighting was delivered and is being stored in a secure location. The contractor doesn't have enough staff to do the installation at this time. The poles are also being stored.
