Call to Order and Roll Call

The June 4, 2024 meeting of the Hammond Port Authority Board of Directors was called to order by Chairman Cantrell at 4:30pm. All five members are present and in person. Chairman Cantrell, Vice Chairman Wojdyla, Secretary/Treasurer Kuhn, Member Kaminsky, and Member Huerta are present and in person.

Chairman Cantrell called for the approval of minutes.

R. Wojdyla made a motion to approve the minutes of May 21, 2024 as presented. D. Kaminsky seconded the motion.

Chairman Cantrell called for the Director's Report.

Port Authority Director J. Smith reported on the following:

Business has been picking up at the marina. The Clipper Room has parties booked through the summer, mostly on the weekends but there are a few parties during the week as well. Memorial Day weekend ended up being pretty slow due to the rainy weather. Last year around this time we had 423 boaters with 60 new boaters, and as of today we have 406 boaters with 65 new boaters. The store has been busy, but we have been able to speed up some cooking processes with a new griddle and a new toaster. On May 21st, there was a boat fire on U dock. Luckily, the boat's fire suppression system put out the fire before any damaged occurred to the dock and minimal damage to the boat. The boat didn't leak any fuel. Our main fire lines at were down because maintenance were repairing a break, and T. Kuhn asked about the portable fire suppression unit we have and why it wasn't out there if we knew the fire line was out. J. Huck said she'll talk to K. Carey about it. Tow boat US took the boat away. The beach is open, and we have lifeguards working every day. The seaweed has been rapidly growing due to the warm winter. Aquatic Control will be here tomorrow to treat it. The Sailing School Open House was this past weekend. The rain kept most of the people away, but a few braved the weather and signed up for classes. June 8th will be the Welcome Back Boaters Party, there will be a DJ and karaoke on the patio. At Lost Marsh Golf Course, N. Sullivan reported that they have been busy even with the rain and cool weather. They have been selling a lot of clothes in the Pro Shop. They are up \$60,000.00 compared to this time last year, and they continue to book outings. The course is looking good, and the maintenance staff is staying busy cutting grass daily. The Pavilion held Leon's Triathlon on Sunday. They are still in the process of cleaning up. Reports say that the number of participants were down compared to last year. Part of the reason may be that it's held early in the season. Hapapalooza went well, it was an all-day event beginning at 11am and ending around 9pm. The Pavilion has a few other events coming up soon: June 8th is a fishing derby, June 13th is the special needs Splash and Dance at the Splash Pad from 6pm-7:45pm, June 15th is Visions of Santana at 7pm, and June 17th is the Dunes Learning Center Summer Camp from 10am-1pm at the docks behind the stage. At Wolf Lake and the parks, the trails are in good shape and the grass is being cut on the daily. The Splash Pad has been busy. NIPSCO came out to look at the building at Amoco Park to have power brought in. They are thinking they can tap a line in the alley between White Oak and Birch, but we are still waiting for the response. The Port Authority will be sponsoring the Festival of the Lakes concert for Blackstreet on July 17th.

Clark Athletic Fields Development Infrastructure- Progress continues to be made on this project.

<u>Fire Station #2-</u> Progress continues to be made on this project. They ran into some blue slag, but the project is still on track to be completed in September.

Marina Administrative Offices/Clipper Room and Boater Facilities Building New Roof- The main office building and the fuel dock roofs still need to be completed. However, Korellis is on strike.

Fuel Dock Underground Storage Tank Update- No updates to report.

<u>N-Dock-</u> D. Button plans to have the install package out in late July, and the dock should be installed at the end of the season. We are planning on ordering the dock accordingly with the bid schedule. Caleb from Baird is continuing to work on the permits that we will need for the project.

<u>McDermott Way at Casino Center Drive Update-</u> Construction started today, and it should take about 2 weeks to complete.

<u>Data Center and Marina Gate Access</u>- The Data Center is going to be funding this project. They may apply to waive the permit fees, but that will be up to the Mayor.

Chairman Cantrell called for Old Business.
