Call to Order and Roll Call

The August 6, 2024 meeting of the Hammond Port Authority Board of Directors was called to order by Chairman Cantrell at 4:30pm. Four members are present and in person, and one member is present via Zoom. Chairman Cantrell, Vice Chairman Wojdyla, Secretary/Treasurer Kuhn, and Member Kaminsky and are present and in person. Member Huerta is present via Zoom.

Chairman Cantrell called for the approval of minutes.

Chairman Cantrell called for the Director's Report.

Port Authority Director J. Smith reported on the following:

This past weekend the marina held a South Shore Bass Open Team Tournament that was sponsored by the South Shore Visitors Center and the Horseshoe Casino. There were about 40 fishermen who entered, with a trophy presentation on Sunday afternoon. There were a variety of vendors, and we hosted a bar out in the parking lot that ended up doing well. The visiting fishermen had great things to say about our marina, and our slipholders enjoyed the event too. Over the weekend, the fuel dock was getting extremely low on fuel, around 3,000 gallons in each tank. Jeff reached out to Kevin Smith to get ahold of the Leopardo representative in hopes of figuring out the communication issues we have been dealing with. Jamie met with Pinkerton yesterday, hopefully our fuel supply getting that low will not be an issue going forward. We are expecting a busy weekend at the marina with the Chicago Air and Water Show going on. Last year around this time, we had 444 boaters with 79 new boaters. This year, we have 438 boaters with 94 new boaters. Lost Marsh Golf Course is looking nice, and they have 16 outings booked for August. The Splash Pad has been busy both during the week and on the weekends. With kids returning to school next week, we are expecting to slow down. The Pavilion hosted WHAM over the weekend. This year there were around 400 bike riders, usually there are closer to 900. Next year we are going to focus more on the advertising and marketing to get more people to participate. There were also concerns about the signage and lighting, which we will address and get it fixed for next year. The ride started at midnight, and the last set of riders came in around 3:30am. The next event at the Pavilion is National Night Out, which is tonight 5pm-8pm. This Saturday, Shining Star: Earth, Wind, and Fire Tribute Band will be playing at the Pavilion beginning at 7pm. Power of Love, Huey Lewis and the News cover band, will be playing at the Pavilion on August 24th. On August 31st, Trippin Billies, a Dave Matthews cover band will wrap up the Summer Concert series at the Pavilion.

Secretary/ Treasurer and Construction Committee Chairman Kuhn reported on the following:

<u>Clark Athletic Fields Development Infrastructure</u>- Progress continues to be made on this project, and the project remains on schedule. The surface coat of asphalt is in. There will be signs installed indicating the lot numbers. Six houses have submitted plans, and one of the houses have closed.

<u>Fire Station #2-</u> Progress continues to be made on this project, however the competition date has been pushed back to October. A lane is closed on Calumet Avenue to do concrete work. The bids for demolition of the current Fire Station #2 will go out as soon as possible so we can get the project started once the firefighters move to the new building.

Marina Administrative Offices/Clipper Room and Boater Facilities Building New Roof-Strike has ended. Koreillis has started working again on the roof.

<u>Fuel Dock Underground Storage Tank Update-</u> No updates to report.

<u>N-Dock</u>- The dock has been ordered, we are expecting to open the bid for installation of the dock by the next meeting.

Amoco Park Electric- We are waiting for the final city inspection.

<u>Data Center and Marina Gate Access</u>- The gate has been installed and is working. There will need to be a device installed that opens when emergency sirens are going off so police and the fire department will be able to get through quickly. There also needs to be a solution for when the power is out, either the gates just stay open or a battery backup.

Chairman Cantrell called for Old Business.
