At the marina, we haven't gotten any additional seasonal slipholders in the past few weeks. This is due to the fact that it's cheaper at this point in the season to pay as a transient. The beach has been closed lately because of the weather and increased E. coli levels, and we are having a harder time staffing the beach with our lifeguards going back to school. J. Huck mentioned that the Dunes beach is now closed Monday-Friday, only open on the weekends. E. Huerta added that Whihala beach closes at 3pm daily. Next season we may look into adjusting our beach hours and schedule to something similar. Lost Marsh Golf Course continues to be busy with regular course play as well as outings. Chicago State University has shown interest in having Lost Marsh as their home course, so N. Sullivan has been in talks with them in regards to that. The Splash Pad is continuously slowing down with the start of school, but we still have been having events at the Pavilion. Shining Star had a great turnout of 400-500 people, and Praise Fest had about 150 people. The next Pavilion events are Power of Love on August 24<sup>th</sup> and Trippin' Billies on August 31<sup>st</sup>.
